Section #2 - Voting

A. Voting Members – Shall be defined as any alumnus of The Chapter who donates more than \$120 pays annual dues in full per year, unless the alumnus is within his first two years of graduating from Oakland University while in good standing with The Chapter, whereby the amount of dues is lowered to one half of the annual dues, to become due on March 16 annually, and can be pro-rated monthly. Voting members will be eligible to vote on all general matters brought before the assembly.
